

TRUST DESCRIPTION

- Alignvest Student Housing Real Estate Investment Trust ("ASH REIT") is the leading Canadian student housing REIT focused on consolidating the fragmented, institutional-grade, purpose-built student accommodation ("PBSA") real estate sector
- ASH REIT is currently the largest PBSA owner and operator by bed count in Canada, with a portfolio of 7,159 beds across 17 properties in seven tier-1 university markets, including Halifax, Montreal, Ottawa, Oshawa, Hamilton, Waterloo, and Edmonton
- ASH REIT is well positioned to offer investors the opportunity to invest in a diversified portfolio of PBSAs across Canada and benefit from its compelling long-term return profile

RECENT UPDATES

- ASH REIT's portfolio is 98.4% leased as of June 20, 2024.
- ASH REIT's portfolio is ~84.4% pre-leased for September 2024 as of June 20, 2024.
- ASH REIT completed the acquisition of three strategic properties in June 2024.
 - Hespeler House and Fergus House in Waterloo, Ontario, each recently constructed 21-storey buildings with 119 furnished units, providing housing to 476 students.
 - The Link in Montreal, Quebec, a newly constructed 18-storey building with 101 furnished units, providing housing for 246 students.

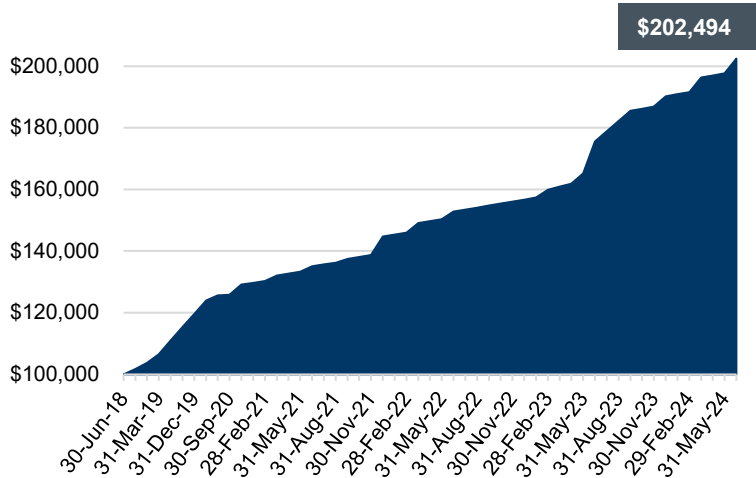

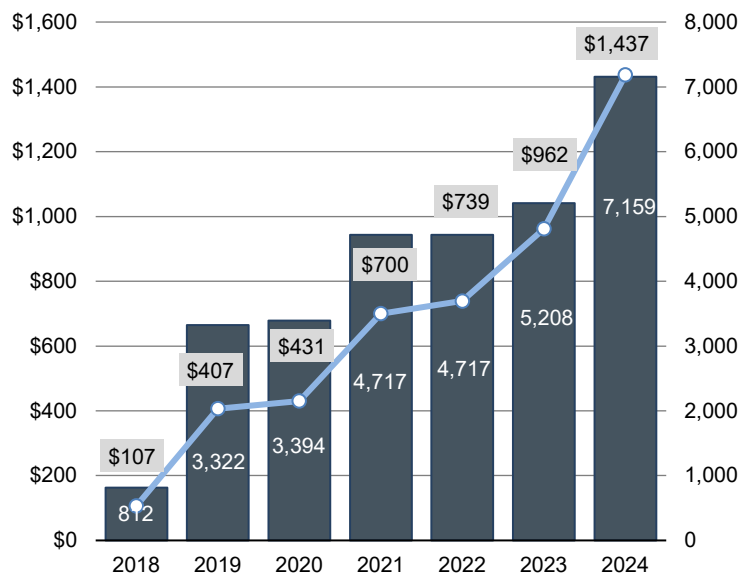
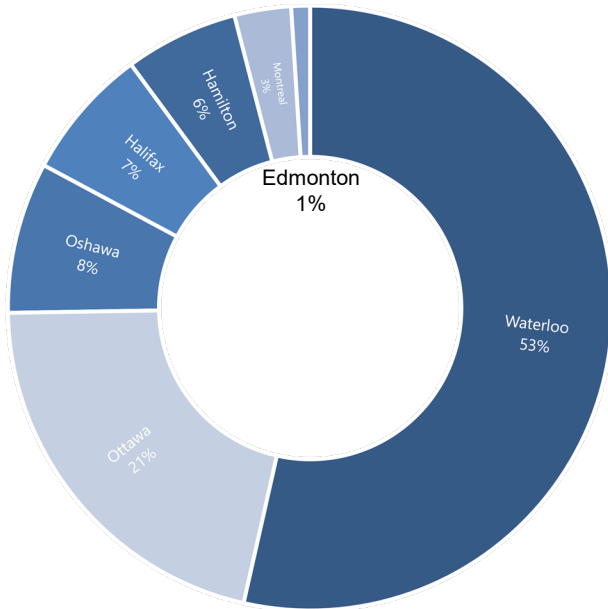

- (1) "Tax-Efficient" means that ASH REIT may have the ability to treat certain distributions as returns of capital, although not guaranteed.
- (2) The targeted return for Class F Units has been prepared by management and has not been independently verified. The targeted returns and net annual yield to Class F Unitholders are targets only and actual results may differ due to a number of factors including changes in the market for student housing and differing fees between the Classes of REIT Units. - (4) Redemption Notice must be received at least 30 days prior to the last day of each month. Class A Units and Class F Units (collectively, the "REIT Units") have the same rights and attributes in all respects with the exception that the Class A Units are indirectly subject to a management fee charged in relation to the corresponding Class A LP Units of Canadian Student Living Group LP ("CSL") to be paid to the general partners of CSL. The general partners of CSL may pay a trailing commission out of its own funds of up to 1% per annum to registered dealers and/or other person legally eligible to accept a commission in connection with their client's holdings of Class A Units.
